



Comments by Big Thicket Association on Draft Jefferson-Orange-Hardin Regional Transportation Study (JOHRTS) Amendment #5, Revisions to Metropolitan Transportation Plan (MTP) 2040

Dear Members of the Transportation Planning Committee and Mr. Dickinson:

The Big Thicket Association (BTA) was formed in 1964 to preserve the diverse ecosystems of the Big Thicket Region. The Association's mission, as a non-profit conservation organization, is to preserve, protect, and promote the Big Thicket region, its natural resources and cultural history through advocacy, education and research. The BTA has joined forces with eight other conservation organizations and established the "Coalition to Oppose Loop 299".

Please be advised that the Big Thicket Association opposes inclusion of FM 299 (MPO Project # 94155; CSJ #071003001) in Amendment #5 of the Metropolitan Transportation Plan revisions, and we ask that the two-lane FM 299 project, listed at \$41,922,000, be removed from the Plan.

FM 299, popularly known as the Vidor Loop, is an expensive project which has a number of problems associated with it. With less than 30% of the engineering design completed, the cost is currently projected at \$53 million. Based upon this cost, Orange County would be required to issue bonds of at least \$40 million to pay for engineering design, environmental studies, permitting, and construction, with ad valorem taxes raised to pay back the loan. While a substantial part of the cost of the project is slated to be reimbursed by TxDOT's pass-through toll financing program, the reimbursement is dependent on the level of vehicle traffic. The traffic projection of 11,800 vehicles/day when the road opens (date unknown), fails to take into account the road improvements, such have expansion of I-10, North FM 105, and Hwy 12, which have improved Vidor's traffic flow. This suggests that the project traffic level will likely be less. If so, the county will have to cover more of the cost. The consultants promoting construction of FM 299 have claimed that the level of "economic development" generated by the road would cover the cost of at least 17 years of the 20-year debt period; however, the promoters have issued no substantiation of this claim. If, as seems likely, this claim proves to be exaggerated, the cost of this project could be financially devastating for a county of fewer than 85,000 residents.

The city councils of five Orange County cities -- Orange, Vidor, West Orange, Bridge City, and Pinehurst -- have adopted resolutions opposing use of county funds for FM 299. More than half of the population of Orange County resides in these five cities – a clear indication that the project does not have popular support.

The entirety of the route of FM 299 is within the 100-year floodplain of the Neches River and either in or affects jurisdictional "waters of the United States," including wetlands of national importance. The US Environmental Protection Agency in 2013 recommended to the US Army Corps of Engineers that a fill permit for the road be denied. TxDOT subsequently withdrew the Clean Water Act fill application for the project. In addition to the wetlands directly impacted, FM 299 can be expected to have negative impacts on the habitat and wildlife of the Big



Thicket National Preserve, arguably the most biologically diverse element of the National Park System. The proposed FM 299 loop roughly parallels two-and-a-half miles of the Preserve, coming within 340 feet of the boundary.

Given the quality of the wetland habitat impacted, and proximity of the project to the Big Thicket National Preserve, the project is likely to require an expensive Environmental Impact Statement (at a minimum extensive environmental studies), resulting in additional costs for extensive mitigation to compensate for the significant loss of wetland function. It is doubtful that the current cost estimate would be adequate to cover these costs, resulting in cost overruns. Further, the impacts may be sufficiently high to result in denial of a federal permit to build FM 299, making FM 299 a high-risk project.

In summary, the Big Thicket Association asks that the Transportation Planning Committee remove FM 299 (MPO Project # 94155; CSJ #071003001) from the Metropolitan Transportation Plan based on lack of need, excessive cost, excessive environmental impact, and the high risk of the project.

Dear Mr. Dickinson:

As an Orange County resident, I write to oppose the inclusion of the following project in the above-referenced MTP amendment and revisions, and ask that it be removed from the Plan:

MPO Project # 94155; CSJ #071003001; FM 299 - construct a new two-lane highway, \$41, 922,000

This is an expensive project that is being claimed as "needed" to reduce traffic on FM 105. It originated in the 1990s when federal highway-aid funds were readily available and was proposed for funding at that time through the Surface Transportation Program (STP), Urban and Rural Aid. However, according to a March 11, 1996 letter from the Beaumont District Engineer of TxDOT to Don Graves, the City Manager of Vidor, the proposed route was never made a priority in the scoring process of the Southeast Texas Regional Planning Commission (SETRPC).

Now, with the relatively limited availability of federal highway-aid and state highway-aid funds, the citizens of Orange County would be required to assume the bulk of financial risk for this road under the TxDOT pass-through toll financing program. With less than 30% of engineering design completed, the cost is currently at \$53 million. Based upon this very preliminary cost, the County would be required to issue bonds of at least \$40 million at minimum to pay for engineering design, environmental studies and permitting, and construction. The ad valorem taxes of Orange County's residents and businesses would be **required** to be raised to pay back the loan. The private promoters of construction of FM 299, and who have now been hired by the Orange County Commissioners--Strategic Planning

and Project Development, Public Werks, and the Community Development Education Foundation--claim that "economic development" that would result from the road would relieve taxpayers from at least 17 years of the 20-year debt period. There is no substantiation of this claim whatsoever, and if the claim proved wrong, the consequence could be financially devastating for Orange County for years. In the meantime, these road promoters would have received their fees from the bond proceeds, and have no personal or business financial stake in the outcome for the people of Orange County.

Because the entirety of the route is in or affects jurisdictional "waters of the US," including wetlands of national significance, the US Environmental Protection Agency (EPA) in 2013 stated to the US Army Corps of Engineers that a fill permit for the road should be **denied**. TxDOT subsequently withdrew the Clean Water Act fill application for the route. Environmental impact studies, mitigation for the loss of significant floodplain capacity and wetlands, and a new Army Corps permitting process will be costly, take years, and may not result in the project being permitted.

The City Councils of Orange, Vidor, West Orange, Bridge City, and Pinehurst have adopted resolutions opposing County funding of this project. Over one-half of the entire population of the County is represented by these votes. Additionally, Vidor officials state that the +20-year old justification for the project is no longer valid based upon other substantial TxDOT investments in the locale, e.g., the I-10 expansion and improvements to North FM 105 and Hwy. 12.

Finally, this proposal for new, expensive construction is inconsistent with several of the planning factors and considerations mandated by Subpart C (Metropolitan Transportation Planning and Programming) of the regulations found at 23 Code of Federal Regulations (CFR) Part 450. These factors include protecting and enhancing the environment and emphasizing the preservation of the existing transportation system. (23 CFR 450.306(a)(5)&(8).) Consideration of these factors "*shall* be reflected" in the metropolitan transportation planning process that is underway. (23 CFR 450.306(b).)

Please ensure that these comments are provided to the Transportation Planning Committee. I look forward to the response, "summary, analysis, and report on the disposition of comments" (mine and others) of the SETRPC "[d]emonstrating explicit consideration and response to public input received during the development of the metropolitan transportation plan" (40 CFR 450.316(a)(1)(vi) & (a)(2).)

While a substantial part of the cost of the project is slated to be reimbursed by TxDOT's pass-through toll financing program, the reimbursement is dependent on the level of vehicle traffic. The traffic projection -- 11,800 vehicles/day when the road opens (date unknown) – fails to take into account the road improvements, such have expansion of I-10, North FM 105, and Hwy 12, which have improved Vidor's traffic flow. This suggests that the project traffic level will likely be less. If so, the county will have to cover more of the cost. The consultants promoting construction of FM 299 have claimed that the level of "economic development" generated by the road would cover the cost of at least 17 years of the 20-year debt period; however, the promoters have issued no substantiation of this claim. If, as seems likely, this

claim proves to be exaggerated, the cost of this project could be financially devastating for a county of fewer than 85,000 residents.

The city councils of five Orange County cities -- Orange, Vidor, West Orange, Bridge City, and Pinehurst -- have adopted resolutions opposing use of county funds for FM 299. More than half of the population of Orange County resides in these five cities – a clear indication that the project does not have popular support.

The entirety of the route of FM 299 is within the 100-year floodplain of the Neches River and either in or affects jurisdictional "waters of the United States," including wetlands of national importance. The US Environmental Protection Agency in 2013 recommended to the US Army Corps of Engineers that a fill permit for the road be denied. TxDOT subsequently withdrew the Clean Water Act fill application for the project. In addition to the wetlands directly impacted, FM 299 can be expected to have negative impacts on the habitat and wildlife of the Big Thicket National Preserve, arguably the most biologically diverse element of the National Park System. The proposed FM 299 loop roughly parallels two-and-a-half miles of the Preserve, coming within 340 feet of the boundary.

Given the quality of the wetland habitat impacted, and proximity of the project to the Big Thicket National Preserve, the project is likely to require an expensive Environmental Impact Statement (at a minimum extensive environmental studies), resulting in additional costs for extensive mitigation to compensate for the significant loss of wetland function. It is doubtful that the current cost estimate would be adequate to cover these costs, resulting in cost overruns. Further, the impacts may be sufficiently high to result in denial of a federal permit to build FM 299, making FM 299 a high-risk project.

In summary, Texas Conservation Alliance asks that the Transportation Planning Committee remove FM 299 (MPO Project # 94155; CSJ #071003001) from the Metropolitan Transportation Plan based on lack of need, excessive cost, excessive environmental impact, and the high risk of the project.

Dear Commission Members:

Please remove the proposed Vidor Loop 299 from the long-range transportation plan. Reasons why this project should not be pursued include:

- There is no demonstrated purpose and need for this project.
- This unneeded road would impose a needless additional tax burden on Orange County taxpayers.
- The preliminary \$53 million cost estimate would certainly go higher if the project were to advance, saddling taxpayers with a second layer of needless tax burden.
- TxDOT's 11,800-vehicles/day projection is almost certainly too high, so, if the road were built, the hoped-for TxDOT reimbursement would shrink and taxpayer liability would grow, adding yet a third layer of needless tax burden.
- Project promoters have published no economic plan or forecast to buttress their claim that "growth" around the proposed road would offset its costs and/or create a net economic gain for the County residents.
- Since the proposed road would be entirely in a flood zone, the roadway's elevated causeway would dam and impede natural flood drainage and shift flooding problems to new areas.
- Any hoped-for new development (with its hoped-for new tax revenue) along the new road would need to be elevated to at least 9 ft. ASL (at least 6 ft above the current flood plain), requiring a huge and costly volume of fill dirt under any residential or commercial projects.
- Development-driven new fill dirt would shift flooding problems to other previously unaffected areas, elevating those property owners' flood risks and flood insurance costs.
- Any new commercial development would compete with downtown Vidor's businesses.
- If the new road is intended to reduce traffic congestion, then direct driveway
 connections to the road should be prohibited; this would necessitate the construction of
 a parallel feeder road infrastructure, all at County expense.
- The proposed road would negatively impact the nearby Big Thicket Natural Preserve, and would damage, destroy, or fragment flood-absorbing wetlands and swamps.

• The city councils of five Orange County cities (including Vidor) -- representing 53% of County residents -- have all voted against spending County funds on this proposal.

I am a resident of Orange County, Texas. I oppose the construction of FM299 for many reasons. I request that you remove it from your Plans and do not allow any future consideration of the proposal.

MPO Project #94155; CSJ #071003001; FM299 – construct a new two-lane highway, \$41,922,000.

The first concern is for the wetlands, trees, wildlife, and water that would be adversely affected by construction of this road. The trees in this area serve to clean the air of pollution from the many vehicles traveling IH-10. This area acts as a water retention pond to hold excess rain water. The proposed road would permanently destroy the natural area. The road will be next to the Big Thicket National Preserve, which will threaten the plants and animals in the Preserve. The many visitors to the Preserve contribute to the economy of this region. The designated area for this road would serve Orange County much better as a preserve, to attract eco-tourism.

Another big concern is for the current residents and businesses of Vidor. This road would in effect be a dam on the west side of Vidor, where rain waters usually drain. This dam would give all the residents of Vidor equal opportunities to FLOOD. If all traffic relocates to a bypass, it will negatively impact Hwy. 105 businesses. The concept for FM299 was developed twenty or more years ago. Much has changed in that time period: widening Hwy. 105, Hwy. 12, and IH-10. The proposed design does not meet current desires of Vidor residents. Cities of Orange, Vidor, Bridge City, and Pinehurst have all passed resolutions opposing Orange County funding this project.

Orange County already has a strained budget. The amount of money that would be borrowed to fund this road is not feasible for Orange County to repay. Taxes would rise to the point that people would be moving out of the county. The promoters of this road claim there will be booming economic development, which would pay for the costs. Who in their right mind would build a new business or a home in a cypress-tupelo swamp floodplain? Who is going to fund the water, sewer and electric services needed for businesses? Orange County already has lots of empty land and buildings that are not being used. Does that sound like businesses are going to storm in here? The promoters for this will probably see financial gains especially if hired by the county whether the road gets built or not. This proposed project offers nothing to Orange County except an unrealistic debt.

The Lone Star Chapter of the Sierra Club (Sierra Club) provides this input into the Draft Jefferson-Orange-Hardin Regional Transportation Study, Amendment #5, Revisions to the 2040 Metropolitan Transportation Plan.

The Sierra Club requests the removal of the 6.2 Mile, Proposed FM 299, New Two-Lane Highway, Pass-Through Road, Orange County, #CSJ 0710-03-001, MPO #94155, from the Metropolitan Transportation Plan. The Sierra Club opposes this road because:

- 1) This new proposed FM 299 has not been justified with an appropriate purpose and need. In particular, the proposal fails to take into account other road projects, like the expansion of Interstate 10, which will reduce significantly or eliminate the supposed purpose and need for proposed FM 299.
- 2) The cost, which at a minimum will be \$53 million, exceeds the ability for Orange County to pay its share and saddles taxpayers with debt that will hang over their necks for decades. Votes have been taken by the elected representatives of 53% of Orange County and these votes have registered as "NO" for proposed FM 299.
- 3) Almost the entirety of proposed FM 299 is in the 100-year floodplain or 100-year floodway. As a result the cost of proposed FM 299 will be significantly higher due to the requirement of raising the road-bed above the 100-year floodplain.
- 4) A portion of proposed FM 299 may be in the 100-year storm surge area and thus be vulnerable to hurricanes and other storms. As climate change continues and worsens and sea level rises, proposed FM 299 will be subject to additional heavy rain events and storms and will be in danger of flooding or having its north and or south entrance-ways flooded, thus eliminating its use and or stranding motorists.
- 5) Most of the right-of-way for proposed FM 299 is not only in the 100-year floodplain but also in jurisdictional wetlands. Enclosed are two maps. One map shows proposed FM 299 alignment. The second map shows that almost the entire length of proposed FM 299 is in wetlands which require that an U.S. Army Corps of Engineers Section 10/404 permit be issued. This means extensive mitigation for wetland losses will be required which will drive up the cost of the proposed FM 299 project.

Proposed FM 299 appears to go through lake, riverine, forested, emergent, aquatic bed, and pond wetlands or waters of the United States. These losses and damage must be mitigated after first avoiding and minimizing environmental impacts. In addition, the road will act as a dam and obstacle for the migration of plants and wildlife in this area and will thus fragment and cut the

connectivity of all of these habitats. Residual environmental impacts that affect the hydrology and water regime of the area and wetlands will cause further cumulative and secondary damage.

- 6) Parts of the Big Thicket National Preserve, Beaumont Unit, exist directly next to proposed FM 299 and environmental impacts may occur on this important federal public land because of the project. Adequate analysis, assessment, and evaluation must be done which ensures that any primary, secondary, or cumulative impacts that occur and negatively impact the Beaumont Unit, due to proposed FM 299, must be avoided, minimized, and mitigated.
- 7) The wetland and other environmental impacts of proposed FM 299 require that an environmental impact statement (EIS) be prepared under the National Environmental Policy Act (NEPA) with citizen input and review and comment. A mitigation plan is required under NEPA and Council on Environmental Quality's (CEQ) NEPA implementing regulations/rules to implement the mitigation plan to reduce environmental impacts. In the CEQ's NEPA implementing regulations, 40 CFR 1508.27, the intensity of environmental impacts must consider:
- a. Impacts that may be both beneficial and adverse. A significant effect may exist even if the Federal agency believes that on balance the effect will be beneficial.
- b. The degree to which the proposed action affects public health or safety.
- c. Unique characteristics of the geographic area such as proximity to historic or cultural resources, park lands, prime farmlands, wetlands, wild and scenic rivers, or ecologically critical areas.
- d. The degree to which the effects on the quality of the human environment are likely to be highly controversial.
- e. The degree to which the possible effects on the human environment are highly uncertain or involve unique or unknown risks.
- f. The degree to which the action may establish a precedent for future actions with significant effects or represents a decision in principal about a future consideration.
- g. Whether the action is related to other actions with individually insignificant but cumulatively significant impacts. "Significance" exists if it is reasonable to anticipate a cumulatively significant impact on the environment. "Significance cannot be avoided by terming an action temporary or by breaking it down into small component parts".
- h. The degree to which the action may adversely affect districts, sites, highways, structures, or objects listed in or eligible for listing in the National Register of Historic Places or may cause loss or destruction of significant scientific, cultural, or historical resources.
- i. The degree to which the action may adversely affect an endangered or threatened species or its habitat that has been determined to be critical under the Endangered Species Act of 1973.
- j. Whether the action threatens a violation of Federal, State, or local law or requirements imposed for the protection of the environment.

If the Southeast Texas Regional Planning Commission does not reject proposed FM 299 the appropriate course of action for Orange County, U.S. Department of Transportation (DOT), Federal Highway Administration (FHWA), and the Texas Department of Transportation (TxDOT) to follow would be to publish a Notice of Intent to prepare an EIS in the Federal Register. This would trigger a several year process to analyze, assess, and evaluate proposed FM 299 and will cost Orange County additional money.

The Sierra Club requests that the Southeast Texas Regional Planning Commission reject proposed FM 299 and remove this project from the Metropolitan Transportation Plan.
