The South East Texas Regional Planning Commission (SETRPC) was designated as the Metropolitan Planning Organization (MPO) for Jefferson, Orange, and Hardin Counties by the Governor of Texas in 1974. The SETRPC-MPO provides a decisionmaking forum for southeast Texas that is responsible for conducting a continuing, cooperative, and comprehensive transportation planning process. The main purpose of the SETRPC-MPO is to develop and maintain all transportation plans for the Jefferson Orange Hardin Regional Transportation Study (JOHRTS) area.

The SETRPC-MPO's short-range transportation plan is the Transportation Improvement Program (TIP), which presents the various highway and transit projects and/or programs that are expected to be implemented or let for construction within the fouryear period of the TIP. All regional transportation projects and programs are required to be identified and prioritized in the TIP to be eligible for federal funding through the Federal Highway Administration or the Federal Transit Administration.

Project schedules often change for a variety of factors; therefore, the TIP may not always yield an up-to-date picture of actual project expenditures. This report provides the list of federally funded transportation projects and programs that were <u>let</u> in federal fiscal year 2019 (FY 2019), the period of October 1, 2018 through September 30, 2019. This report complies with 23 CFR §450.332 "Annual Listing of Obligated Projects" and was prepared cooperatively by the South East Texas Regional Planning Commission – Metropolitan Planning Organization (SETRPC-MPO) for the JOHRTS area and the Texas Department of Transportation – Beaumont District.

The following categories are developed by the Texas Department of Transportation (TxDOT).

2	<b>Metropolitan and Urban Area Corridor Projects</b> (roadway mobility improvements within metropolitan MPO boundaries, including traffic management, hurricane evacuation, toll projects, and North American Free Trade Agreement (NAFTA) improvements, roadway mobility improvements within urban MPO boundaries, including traffic management, hurricane evacuation, toll projects, and NAFTA improvements)
3	Non-Traditionally Funded Transportation Projects (concession and surplus toll revenue funded projects)
4	<b>Statewide Connectivity Corridor Projects</b> (roadway mobility improvements outside any MPO boundaries, including traffic management, hurricane evacuation, toll projects, and NAFTA improvements)
5	<b>Congestion Mitigation and Air Quality Improvement</b> (transportation projects that address the congestion mitigation and air quality improvements in non-attainment areas)
6	<b>Structures Replacement and Rehabilitation</b> (bridge rehabilitation and maintenance projects, including railroad grade separations that are either on or off the TxDOT roadway system)
7	<b>Metropolitan Mobility &amp; Rehabilitation</b> (transportation projects for urbanized areas with a population of 200,000 or more persons) *
8	<b>Safety</b> (transportation projects that mainly consist of safety improvements) *

9	<b>Transportation Enhancements</b> (transportation projects that qualify for TxDOT's Transportation Enhancement program) *
10	<b>Supplemental Transportation Projects</b> (specialty projects like State Park roads and those that do not qualify for other categories)
11	<b>District Discretionary</b> (urban and rural mobility projects and other miscellaneous projects selected by District Engineer)
